Detailed Design for Markham Centre Trails Phase IV

Contract: 099-R-24

The City of Markham is committed to building a safe and well-connected trail network. In February 2024, the City completed the Markham Centre Trails Master Plan Study, to develop a continuous trail network through the Markham Centre Greenlands, consistent with the City's Active transportation and recreation trail policies and plans. In September 2024, the City retained Aquafor Beech Limited, to provide consulting services for this project. As recommended in the approved Master Plan, the City has completed the preliminary design for "Markham Centre Trails Phase IV", to connect the Rouge River Valley corridor between Apple Creek Boulevard and Highway 7.

As public consultation is an important part of City projects, the City will be holding an inperson Community Engagement Session where the ongoing design will be discussed.


Additionally, this session will showcase the potential trail impacts to the neighboring residents and proposed mitigation measures.
