# **DEFINITION OF APPLICATION TYPES**



#### Official Plan Amendment

The process through which changes are made to the City's Official Plan. A document, containing policies which guide the future development of land in Markham. The Official Plan also includes a framework for establishing regulations and standards for land use and contains policies on how the City will manage growth.

### **Zoning By-Law Amendment**

The process through which the City guides and approves changes to how lands are used for specific purposes. The process also addresses related development standards such as property setbacks, building height, and parking.

#### Plan of Subdivision

The process through which the City guides and approves the design and layout of building lots and roads (neighborhoods).

#### **Site Plan Control**

The process through which the City guides and approves the layout of building elevation, landscape and site circulation.

### Condo

The process through which the City guides and approves the development of condominiums.
